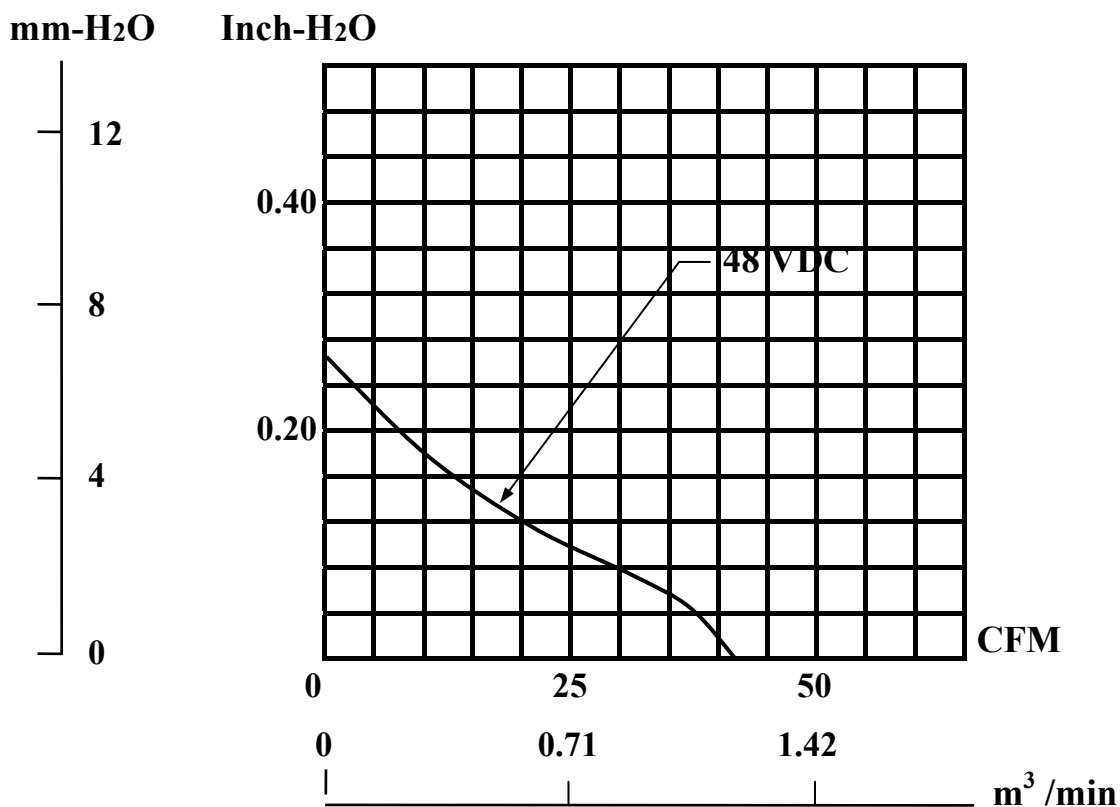

PERFORMANCE CURVES

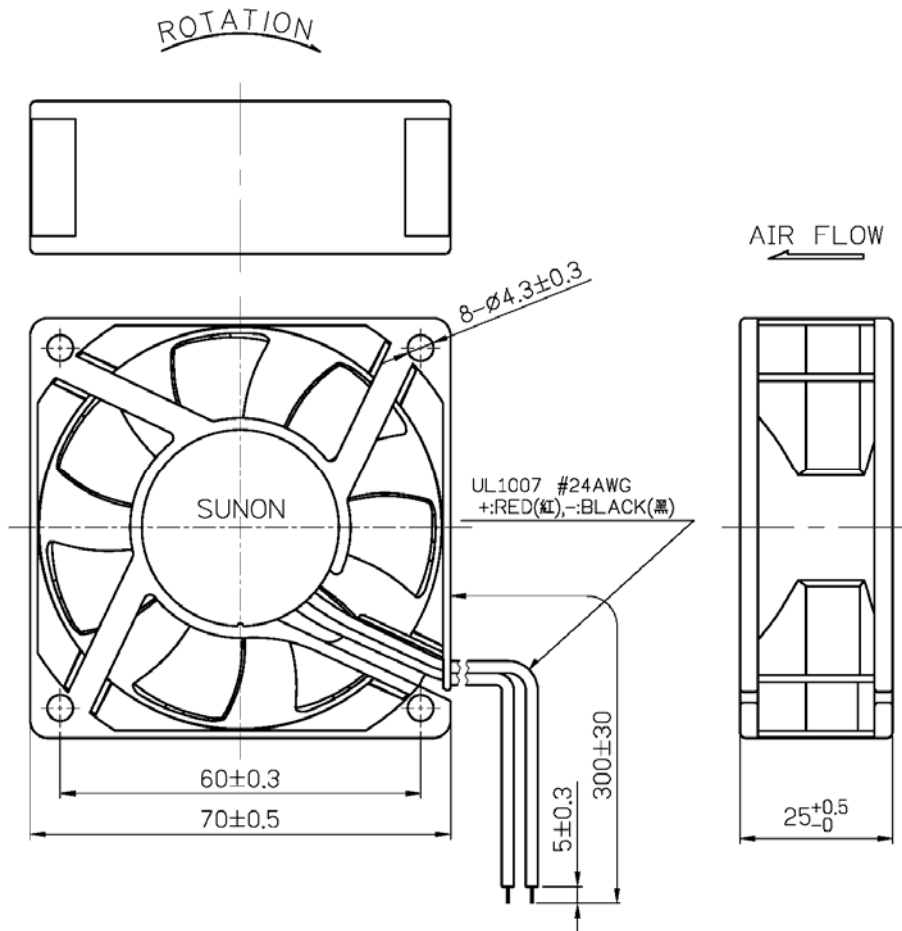
