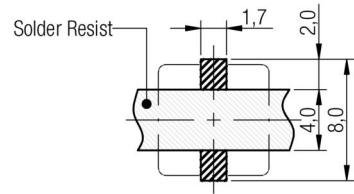

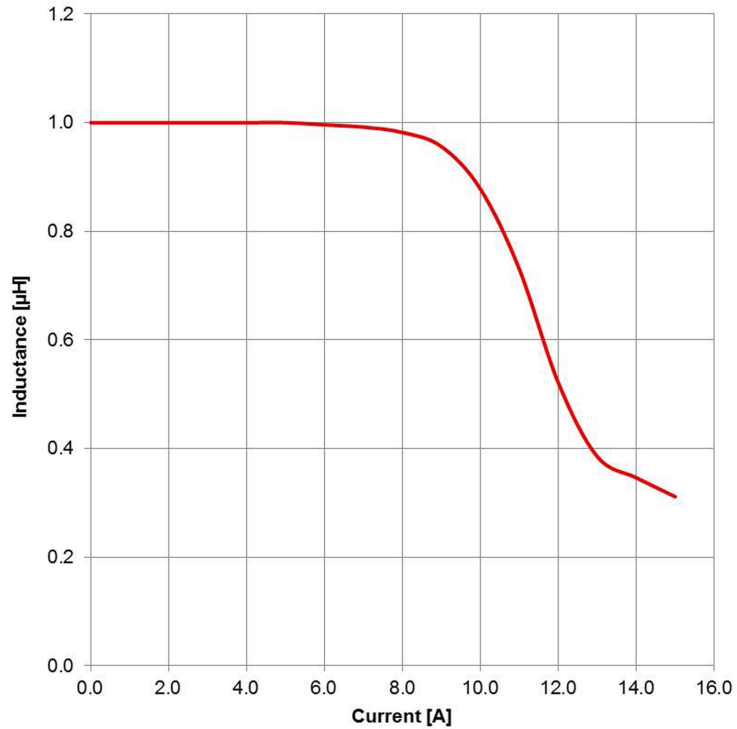

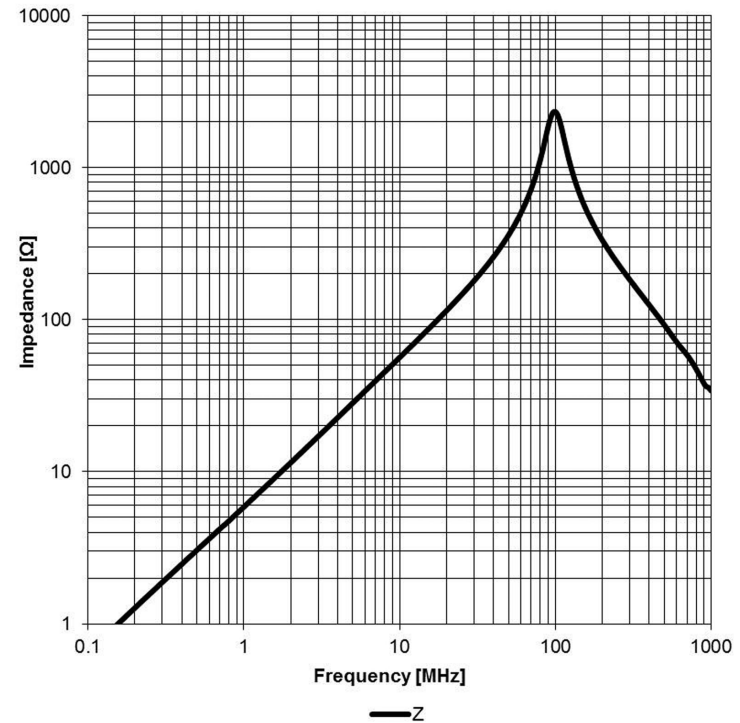


Product specific:


